COVID-19 PARENT/PLAYER CONSENT FORM**

**Assumption of the Risk and
Waiver of Liability Relating to Coronavirus/COVID-19**

The novel coronavirus, COVID-19, has been declared a pandemic by the World Health Organization. I agree that I am personally responsible for my safety and the actions of my child while participating in youth sports, including practices, games, tournaments, meetings, or other activities that are part of the Belfry Hockey and/or Columbus Youth Development Association (CYDA) programming. I agree to comply with all applicable rink, facility, and governmental rules and applicable laws, policies, or regulations while participating in Belfry Hockey or CYDA events. Because the facilities we will be in are open for use by other individuals, I recognize that attending CYDA or Belfry Hockey events could increase my and my child(ren)'s risk of contracting COVID-19.

I confirm and represent that I will not attend any Belfry Hockey or CYDA function or event if I or my child has any of the following symptoms of COVID-19:

Fever, Shortness of Breath, Loss of Sense of Taste or Smell, Dry Cough, Runny Nose, Sore Throat

I acknowledge and agree that by participating in any Belfry Hockey or CYDA event, I am voluntarily assuming the risk that my child(ren), myself, my significant other and family member I may be exposed to or infected by COVID-19, influenza, or another infectious disease at a Belfry Hockey or CYDA event and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19, influenza or another infectious disease at a rink or other facility where Belfry Hockey, CYDA or other activities may occur, and that this risk may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Belfry Hockey or CYDA agents, employees, volunteers, and program participants and their families.

With full awareness and appreciation of the risks involved, I, for myself on and on behalf of my children, family, spouse, estate, heirs, executors, administrators, assigns, and personal representatives hereby forever waive, discharge and covenant not to sue Belfry Hockey, CYDA, and their respective officers, directors, Board Members, administrators, coaches, employees, agents, and volunteers (collectively the "Released Parties") from any liability and claims arising out of or relating to any injury, sickness, illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my or my child(ren)'s attendance at any Belfry Hockey or CYDA event or related activity ("Claims"). I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of any Released Parties, regardless of when a Claim occurs or accrues.
